## RESOLUTION 2024-86

**A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIMAS, CALIFORNIA, COUNTY OF LOS ANGELES AND THE CITY OF SAN DIMAS AS SUCCESSOR AGENCY TO THE SAN DIMAS REDEVLEOPMENT AGENCY, APPROVING THE JULY 1, 2025 THROUGH JUNE 30, 2026 RECOGNIZED OBLIGATION PAYMENT SCHEDULE FOR THE SUCCESSOR AGENCY OF THE FORMER REDEVELOPMENT AGENCY TO THE CITY OF SAN DIMAS PURSUANT TO HEALTH AND SAFETY CODE SECTION 34180 (g)**

**WHEREAS**, pursuant to AB x 126, enacted on June 28, 2011, and as subsequently amended by AB 1484, SB 341, and SB 107 ("Dissolution Act"), the Redevelopment Agency to the City of the City of San Dimas was dissolved as of February 1, 2012, and the City of San Dimas elected to serve as the Successor Agency to the former Redevelopment Agency to the City of San Dimas, and

**WHEREAS**, California Health & Safety Code Sections 34177 (l) (2) (A) requires the Successor Agency to prepare a Recognized Obligation Payment Schedule ("ROPS") and make associated notifications and distributions; and

**WHEREAS**, the ROPS must be distributed to and approved by the Fifth District Consolidated Oversight Board at its January 13, 2025 meeting pursuant to Health and Safety Code Section 34180 (g) and 34177 (j) prior to submittal to the Department of Finance by the February 1<sup>st</sup> 2025 deadline.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of San Dimas does hereby resolve that:

**SECTION 1.** The forgoing Recitals are true and correct and are incorporated herein.

**SECTION 2.** The Successor Agency Board approves the ROPS for the period July 1, 2025 through June 30, 2026 and directs the Successor Agency Executive Director, or their designee, to file, post, mail and otherwise deliver via electronic mail, internet posting, and /or hardcopy, all notices and transmittals necessary or convenient in connection with the approval of the ROPS.


